Conditions of the Mahapola Higher Education Scholarship Trust Fund

The following requirements and conditions will apply with regard to entitlement for Mahapola Scholarships and receipt of Mahapola Scholarship installment payments during period of studies.

- 1. Monthly scholarship installments will be paid based on the recommendations by the relevant university on the progress made by the scholarship recipient on studies for which the scholarship was awarded.
 - 1.1. Scholarship installments will be paid up to a maximum of 10 installments per academic year for the full duration of the study course on University. only 9 installments will be paid for the students of Sri Lanka Institute of advanced Technical Education.
 - 1.2. Student should be engaged in full time studies to be entitled to the scholarship payments and no payments will be made for those who do not participate in full time studies.
 - 1.3. The Scholarship installments will be paid at the University/Institute to which the student is attached and only one scholarship installments per month will be released for payment.
 - 1.4. Scholarship installments should be collected regularly and uncollected installments will be treated as unneeded and abandoned installments, such installments will not be re-paid unless under exceptional circumstances.
 - 1.5. After acceptance of this scholarship, the student will not be entitled to receive any other scholarship or bursary connected with this same course of studies or any other course of studies. In case the students become eligible for another such scholarship he/she will have the option either to retain the former scholarship only or to have the former scholarship cancelled and commence to receive payments under the new scholarship. In either case the student should notify this office immediately.
- 2. Following another course of studies in lieu of the study course for which this scholarship has been awarded. Non participation in studies, prolonged absence form studies, failure at yearly examinations, abandonment of the study course, etc. will result in the **cancellation of your scholarship**.
 - 2.1. Non-participation in lectures, tutorial classes and practical connected with the study course, followed by reports to that effect by the University could also result in the suspension or cancellation of the scholarship. Guilty on act of misconduct scholarship will be cancelled.
 - 2.2. If the student engages himself in business or employment during the course of his studies or if there is an increases in income levels during that period, these factors too will result in the discontinuance of the scholarship payment
- 3. In the event of a student obtaining permission for postponement of his/her studies, on unavoidable and uncontrollable circumstances he/she should produce the relevant letter of authority to the Mahapola Scholarship Trust Fund and state whether he/she proposes to secure the scholarship next year. Such request will be entertained up to a maximum of one year's postponement of the scholarship. Even in a case of **postponement of studies,** the student should accept the award at the first award ceremony to be entitled to the scholarship.

- 4. If the study course in the university is later changed. Such a student is found eligible for a Mahapola scholarship under the new study course, based on the marks scored, he/she will then be awarded a new scholarship, Based on the recommendation of the University Grants Commission. In such case, the student should notify this office immediately about the change in the study course.
- 5. The decision of the Mahapola Higher Education Scholarship Trust Fund on matters relating to the scholarship, as well as to scholarship payments, will be treated final.

මහපොළ ශිෂාත්වයට හිමිකම් ලැබීමට හා එම ශිෂාත්වය වෙනුවෙන් ගෙවන ශිෂාත්ව වාරික මුදල් පාඨමාලාවේ අධායන කාලය තුලදී ලබා ගැනීමට පහත සඳහන් අවශාතා හා කොන්දේසි අදල වේ.

- ශිෂාත්වය පුදනය කරනු ලැබ ඇති පායිමාලාවේ, ශිෂාත්වලාභියා විසින් අධායන කටයුතු වලින් ලබා ගන්නා පුගතිය මත විශ්ව විදාහලයේ නිර්දේශය අනුව, ශිෂාත්ව වාරික මුදල් මාසිකව ගෙවනු ලැබේ.
 - 1.1 විශ්ව විදහාල ශිෂහත්ව සඳහා අධායන වර්ෂයකට වාරික 10 ක උපරිමයකට යටත්ව පාඨමාලාවට නියමිත අධායන වර්ෂ ගණන සඳහා පමණක් ශිෂහත්ව වාරික ගෙවනු ලැබේ. ශ්‍රී ලංකා උසස් තාක්ෂණ අධාහපන ආයතනයේ සිසුන් සඳහා එක් අධායන වර්ෂයකට වාරික 9ක් බැගින් ගෙවනු ලැබේ.
 - 1.2 මෙම ශිෂපත්ව වාරික ලබා ගැනීම සඳහා පූර්ණකාලීනව පාඨමාලාවේ නිරත විය යුතු අතර, පාඨමාලාවට පූර්ණකාලීනව සහභාගී නොවන අයට ශිෂපත්ව වාරික ගෙවනු නොලැබේ.
 - 1.3 පාර්මාලාව පැවැත්වෙන කාලය තුලදී මසකට එක් ශිෂාත්ව වාරිකය බැගින් පමණක් ශිෂායා ඉගෙනුම ලබන විශ්ව විදුසාලයේදී / අධාාපන ආයතනයේදී ගෙවනු ලැබේ.
 - 1.4 ශිෂාත්ව වාරික නිසි පරිදි ලබාගත යුතුය. ලබා නොගත් වාරික අනවශා හා අත්හැර දමූ ශිෂාත්ව වාරික ලෙස සලකනු ලැබේ. එවැනි වාරික අති විශේෂ හේතුවකින් තොරව නැවත නොගෙවනු ඇත.

1.5 මෙම ශිෂපත්වය භාර ගැනීමෙන් පසුව මෙම පාඨමාලාවට හෝ වෙනත් පාඨමාලාවකට හෝ ඔබට වෙනත් කිසිදු ශිෂපත්වයක් හෝ ශිෂපාධාර මුදලක් ලබා ගැනීමට අවසර නැත. වෙනත් ශිෂපත්වයකට හිමිකම් ලබන ශිෂපයෙකු ඔහුට / ඇයට මනාපය පරිදි පළමු ශිෂපත්වයේම පමණක් රැදී සිටීම හෝ පළමු ශිෂපත්වය අවලංගු කර නව ශිෂපත්වය ලබා ගැනීම හෝ සිදුකළ හැකිය. එවැනි සිදුවීම වලදී ශිෂපයා විසින් වහාම මෙම කාර්යාලය වෙත දුනුම් දිය යුතුය.

 ශිෂපත්වය සඳහා තේරී ඇති පාඨමාලාව වෙනුවට වෙනත් පාඨමාලාවක් හැදරීම, පාඨමාලාවට සහභාගී නොවීම, දීර්ඝකාලීනව පාඨමාලාවට සහභාගී නොවීම, වාර්ෂික විභාග අසමත්වීම, පාඨමාලාව අත්හැරයාම ආදී කරුණු ශිෂපත්වය අවලංශු වීමට හේතුවේ.

2.1 පාර්මාලාවට නියමික දේශන, නිබන්ධන පන්ති හා ප්‍රායෝගික පන්ති ආදී පාර්මාලාවේ කටයුතුවලට විධිමත් පරිදි, සහහාගී නොවීම, නොපැමිණීම පිළිබඳ විශ්ව විදහාලයයෙන් ඉදිරිපත් කරන වාර්තා අනුව ශිෂනත්වය අත්හිටුවීම හෝ අවලංගුවීම හෝ සිදුවනු ඇත. විෂමාචාර පිළිබඳ වැරදිවලදී ශිෂනත්වය අවලංගු වනු ඇත.

- 2.2 ආදයම් ලැබීම පිණිස වාහපාරයක, සේවයක හෝ රැකියාවක නියුක්ත වීම හා ආදයමේ වැඩිවීම යන හේතුද මෙම ශිෂයත්ව වාරික මුදල් සහ හිමිකම් නොලැබීමට හේතුවනු ඇත.
- 3. ශිෂපයාගේ පාලනයෙන් බැහැර වූ නොවැලැක්විය හැකි හේතූන් මත ශිෂපයා විසින් තම අධානපන කටයුතු කල් ගනු ලබන අවස්ථාවේදී ඔහු/ඇය විසින් තමන්ට ඊලඟ වර්ෂයේදී අධානපන කටයුතු හැදරීම සඳහා අවසර දී ඇති ලිපිය ඉදිරිපත් කරමින් ඊළඟ වර්ෂයේදී මෙම ශිෂපත්වය ලබා ගැනීමට බලාපොරොත්තු වන්නේ නම ඒ බව සඳහන් කරමින් මහපොළ ශිෂපත්ව අරමුදල වෙත දන්වා සිටිය යුතුය. එවැනි ඉල්ලීම් සඳහා අවසර දෙනු ලබන්නේ එක් වර්ෂයකට පමණි. එවැනි කල්ගැනීම් වලදී වුවද තම ශිෂපත්වය සඳහා හිමිකම් ලැබීමට නම් ශිෂපයා විසින් පළමුව ශිෂපත්ව පුදනයේදී සිය ශිෂපත්ව සහතිකය ලබාගත යුතුය.

 - 1,3 மாணவர் இணைக்கப்படுள்ள பல்கலைக்கழகத்திற்கு புலமைப் பரிசுத் தவணைக் கட்டணங்கள் செலுத்தப்படுவதுடன் மாதாந்தம் ஒரேயொரு தடவை மாத்திரம் ஒரு புலமைப் பரிசுத் தவணைக் கட்டணம் கொடுப்பனவிற்கென விடுவிக்கப்படும்.

- 5. The decision of the Mahapola Higher Education Scholarship Trust Fund on matters relating to the Scholarship, as well as to Scholarship payments, will be treated final.
