- 2. The Borrower hereby promises and agrees to repay to the University the said sum of Rs..... together with interest at four point two percent (4.2%) per annum by installments as determined by the Council.
- 3. The Borrower also hereby authorizes the University to deduct the installments monthly from the salary payable to him as an employee of the University.
- 4. The Borrower also hereby consents and agrees;
  - 1. To purchase the personal computer outright and not on hire-purchase terms.
  - 2. To utilize the entire loan for the purchase of the personal computer, and to produce the supplier's cash receipts in evidence of such purchase within one month from the date of receipt of the loan, for inspection by the Bursar or Assistant Bursar, of the University.
- 5. And it is hereby mutually agreed by and between the parties as follows.
  - 1. The liability of the Borrower to repay to the University the full amount advanced as aforesaid shall in no way be affected by any accident, damage to or loss of the microcomputer.
  - 2. The full amount of the said advance or such portion thereof as may be due for the time being, together with interest, shall forthwith become payable to the University, anything herein to the contrary notwithstanding,
  - a. If the Borrower ceases to be employed by the University.
  - b. On the death of the Borrower
  - c. If the Borrower shall commit any breach of the terms of this agreement.
