- 11. Sealed bids shall be submitted on the forms available with the Bidding Documents. Duly completed bids together with the duplicate and the bid security should be inserted in a sealed envelope or packet and should be indicated the name of the contract and contract number on top left hand corner of the each envelop. (Bid security should be submitted along with the original bidding document).
- 12. All bids must be accompanied by a Bid Security as mentioned above.
- 13. Late bids will be rejected. The bids shall be deposited in the 'Tender Box' available in the Registrar's Office of the University, or sent under registered post to be received before the deadline at the address given below. The bids will be opened immediately after closing of the Bids on 30.05.2019 in the presence of the bidders or their authorized representatives who choose to attend the bid opening.
