The University of Colombo will entertain applications from suitably qualified persons for the above Post up to 05th August 2021.

(01) QUALIFICATIONS

(1) (i) A Degree with specialisation in **Finance** with First or Second Class (Upper Division) Honours;

<u>OR</u>

(ii) A Degree with specialisation in **Finance** with Second Class (Lower Division) Honours;

OR

(iii) (a) A Degree with specialisation in **Finance** without honours or any other Degree with at least Second Class honours.

<u>and</u>

(b) (i) A Doctoral Degree in Finance

or

(ii) A Masters Degree in **Finance** obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/dissertation

or

(iii) A full time Masters Degree in **Finance** of a minimum of 18 months duration with at least 60 credits* of which not less than 15 credits* of research by way of thesis/dissertation {*One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)}

OR

(iv) Such academic or professional qualifications or professional experience as may be approved by the University Grants Commission upon the recommendation of the University of Colombo.

AND

(2) (i) A Doctoral Degree in **Finance**

OR

(ii) a. A Masters Degree in **Finance** obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/dissertation

or

b. A full time Masters Degree in **Finance** of a minimum of 18 months duration with at least 60 credits* of which not less than 15 credits* of research by way of thesis/dissertation [*One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]

or

c. Such professional qualifications and experience as may be approved by the University Grants Commission upon the recommendation of this University.

and

Those who do not possess a Doctoral degree should have fifteen (15) publications to the credit of the applicant in indexed journals.

AND

(3) Fifteen (15) years of experience after obtaining the qualifications specified under 01(1) on page 1.

AND

(4) Obtain at least the minimum mark laid down in the Marking Scheme for Professorship.

NOTE:

An applicant who qualifies only under (01)(1)(iii) above may be exempted from (01)(2) above if the applicant has a Doctoral Degree in the relevant field.

Method of Application

Applicants for the *Post of Professor* are requested to submit the following.

- (a) Application Form
 - (Download from the University website www.cmb.ac.lk/notices/vacancies)
- (b) 18 copies of his/her Curriculum Vitae
- (c) 18 copies of self-assessment of his/her whole career that lists and specifies the contribution to:
 - Teaching, Scholarship and Academic Development

- Research, Scholarship and Creative Work
- Dissemination of Knowledge
- Awards, University, National and International Development Activities

The Self-Assessment should be prepared in accordance with the marking scheme, (issued with this document) giving details under each heading/sub heading.

- (c) Three copies each of the documents to support self-assessment in
 - Teaching, Scholarship and Academic Development (Section 1.0)
 - Research, Scholarship and Creative Work (Section 2.0)
 - Dissemination of Knowledge (Section 3.1)
 - Awards, University, National and International Development Activities and other relevant documents listed in the self-assessment. (Section 3.2 & 3.3)
- Note: Section 2 & 3.1 should be prepared as separate documents
- (e) Titles of five (05) outstanding research publications/research papers by the candidate.

These documents shall be sent to the Vice Chancellor by each applicant with a covering letter applying for the position, affirming their authenticity.

02. SALARY AND OTHER CONDITIONS OF APPOINTMENT:

Professor [U-AC5(II)]: Rs. $117,350 - 13 \times 2700 - 152,450 \text{ p.m.}$ (as at 01-01-2020)

Senior Professor [U-AC5(I)] :Rs. $139,175 - 11 \times 2925 - 171,350$ p.m. (as at 01-01-2020)

The selected candidate will be on probation for a period of three (03) years. However, a person who has been previously confirmed in any other post of teacher in this University if appointed will have to serve a period of probation of one (01) year.

The selected candidate if presently serving in the Government Department will have to obtain his/her release through the Ministry of Public Administration. Government servants will not be entitled to maintain their pension rights whilst in the University service.

The selected candidate will become a member of the Universities Provident Fund as well as of the Universities Pension Scheme. He/She will contribute 10% of his/her monthly salary to the Universities Provident Fund and at the same time the employer will make a total contribution of 15% of his/her salary of which 8% will be credited to the Universities Pension Fund and 7% to the Universities Provident Fund.

The selected candidate will be placed on an appropriate step of the relevant salary scale and position that are commensurate with his/her experience and position held by him/her in the University System.

Applicants should be able to teach in Sinhala/Tamil and English.

The other conditions of appointment will be in accordance with the provisions of the Universities Act No. 16 of 1978, Universities (Amendment) Act No. 7 of 1985 and Universities (Amendment) Act No. 1 of 1995 and Ordinances, By-laws, Regulations and Rules etc., made thereunder.

IMPORTANT:

Applicants from Higher Educational Institutions, Government Departments and Government Corporations should apply through the Heads of such Institutions. Applications which do not confirm to this requirement will be rejected.
